1. What Are Cookies

Cookies may collect certain information such as:

- Pages visited
- Time spent on the website

This information helps improve the performance and usability of the website.

2. How We Use Cookies

Essential Cookies

These cookies are necessary for the basic functionality of the website, such as:

Without these cookies, certain parts of the website may not function properly.

Performance and Analytics Cookies

These cookies help us understand how visitors use our website by collecting information such as:

- Number of visitors
- Pages viewed
- Website traffic sources

This allows us to improve the performance and user experience of our website.

Marketing Cookies

With your consent, cookies may be used to:

- Provide relevant advertisements
- Track marketing campaign performance
- Help us communicate relevant promotions or updates

3. Consent to Use Cookies

We use a cookie consent banner that allows you to:

- Accept all cookies
- Reject non-essential cookies
- Customize your cookie preferences

Non-essential cookies (such as analytics and marketing cookies) will only be placed on your device with your consent.

You may withdraw or change your consent at any time by adjusting your browser settings or revisiting the cookie settings on our website.

4. Third-Party Cookies

Some cookies may be placed by third-party services that appear on our website. These may include services such as:

- Website analytics providers (e.g. Google Analytics).
- Social media platforms (e.g. Facebook).
- Booking or enquiry systems.

These third parties may collect and process information according to their own privacy policies. We encourage you to review their policies for more information.

5. Cookie Duration

Cookies may be stored for different periods, including:

- Session cookies: Deleted when you close your browser.
- Persistent Cookies: Remain on your device for a set period or until deleted.

The duration depends on the purpose of the cookie.

6. Managing Cookies

Most web browsers allow you to control or disable cookies through the browser settings.

You can:

- Block cookies.
- Delete existing cookies.
- Receive notifications when cookies are placed.

Please note that disabling cookies may affect the functionality of certain parts of the website.
